IT IS notified for the general information of the public that the Cabinet Secretary for Sports, Culture and Heritage has appointed the Ushanga Kenya Steering Committee for the implementation of the Ushanga Kenya Initiative and which shall comprise of:

The Project Co-ordinator

1. The Ushanga Kenya Initiative Steering Committee shall be the apex governance body for the implementation of the Ushanga Kenya Initiative.

2. The Ushanga Kenya Initiative is a National Government flagship project for the empowerment of pastoral women and girls involved in beadwork (Ushanga) by transforming their art for significant socio-economic benefit through mobilisation of the women and girls into organised groups, capacity building, the provision of infrastructure, value-addition, and the facilitation of access to mass and niche markets at local, national, regional and international platforms.

3. The target counties shall comprise of Baringo, Kajiado, Marsabit, Narok, Samburu, Turkana and West Pokot counties.

4. The Terms of Reference of the Steering Committee shall be to—

- (a) provide policy guidance for and oversight over the Ushanga Kenya Initiative in accordance with the Culture and Heritage Policy framework;
- (b) co-ordinate actions at National and County levels to resolve any matters brought to the Steering Committee for review;
- (c) endorse the Ushanga Kenya Initiative annual work plans as may be approved by the Accounting Officer;
- (d) review of budgets of the Ushanga Kenya Initiative as approved by the Accounting Officer;
- (e) review the annual report and any other reports of the Ushanga Kenya Initiative as may be approved by the Accounting Officer;
- (f) review Ushanga Kenya Initiative expenditures in line with the work plans approved by the Accounting Officer;

(g) commission the preparation of reports including annual reports, audit reports, mid-term and end-term reports and other researches that may better inform the better execution of the Steering Committee's mandate;

(h) perform any other duties that are necessary or expedient for the execution of the Steering Committee's mandate; and

(i) undertake such other tasks as may be assigned to the Steering Committee by the Cabinet Secretary from time to time.

5. In the performance of its functions, the Steering Committee—

(a) shall regulate its own procedure;

(b) shall hold meetings at least once in every three months as convened by the chairperson at such places as the Steering Committee shall consider desirable;

(c) may hold such special meetings as may be convened by the chairperson at such places as the Steering Committee shall consider desirable; and

(d) may co-opt such other persons with the necessary expertise to assist the Steering Committee in the execution of its mandate.

6. There shall be a Secretariat to assist the Steering Committee in the execution of its mandate which shall comprise of—

(a) the Project Co-ordinator, who shall be the head of the Secretariat; and

(b) such other persons as may be deemed necessary by the Steering Committee for the operations of the Secretariat.

7. The Secretariat shall—

(a) be responsible for the day-to-day operations of the Ushanga Kenya Initiative;

(b) undertake a mapping and profiling exercise of the status of the beadwork industry in Kenya and, more specifically, in the target counties;

(c) promote entrepreneurship and commercialisation in the beadwork industry through the training and capacity-building of women and girls from pastoral communities in the target counties;

(d) strengthen the empowerment of women and girls from the pastoral communities in the target counties in decision-making;

(e) support women and girls in the target counties through the promotion of beadwork product quality, value-addition and marketing;

(f) raise awareness on the cultural and economic value of beadwork especially in critical supporting sectors including the hospitality industry, industrialisation, labour and technical education;

(g) support and promote the marketing and visibility of beadwork through the provision of duty-free spaces, cultural premises and the exploration of markets and other visibility opportunities;

(h) collaborate with all relevant stakeholders and promote stakeholders' active participation in the Ushanga Kenya Initiative;

(i) report at least once in every three months to the Steering Committee on the activities undertaken under the Ushanga Kenya Initiative and obtain overall vision and policy guidance from the Steering Committee; and

(j) perform any other tasks for the achievement of the goals of the Ushanga Kenya Initiative as may be directed by the Steering Committee.

8. The funds of the Ushanga Initiative shall comprise of monies—

(a) provided out of the voted funds of the Ministry of Sports, Culture and Heritage;

(b) provided by the governments of the target counties as may be appropriated for the purposes of the Ushanga Kenya Initiative;

(c) provided from the Sports, Arts and Social Development Fund; and

(d) received as grants, gifts or donations from well-wishers, sponsors and other development partners.

9. The members of the Steering Committee and Secretariat shall serve for a term of three (3) years, with effect from the 17th July, 2020.

10. The Secretariat of the Committee shall be based at the headquarters of the Ministry of Sports, Culture and Heritage.
