**THE TANA RIVER COUNTY SUPPLEMENTARY
APPROPRIATION ACT, 2020**

AN ACT of the County Assembly of Tana River to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending 30th June, 2020; and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Tana River as follows—

Citation and Commencement

1. This act may be cited as the Tana River County Supplementary Appropriation Act, 2020 and shall come into force upon Publication in the *Kenya gazette*.
