**THE ELGEYO /MARAkwET COUNTY
SUPPLEMENTARY APPROPRIATION ACT, 2018**

No. 1 of 2018

Date of Assent: 2nd March, 2018

Date of Commencement: 7th March, 2018

AN ACT of the County Assembly of Elgeyo/Marakwet to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the Financial Year ending on the 30th June, 2018, and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Elgeyo/Marakwet, as follows—

1. This Act may be cited as the Elgeyo/Marakwet County Supplementary Appropriation Act, 2018. Short title.

2. The County Treasury may issue the sum of Kenya Shillings **Four Billion, Nine Hundred and Forty Four Million, Six Hundred and Eighty Seven Thousand and Six Hundred and Sixty Nine Shillings only (KSh. 4,944,687,669)**, out of the County Revenue Fund and apply it towards the supplies and services granted for the Financial Year ending on the 30th June, 2018. Issue of KSh. 4,944,687,669 Out of the Consolidated Fund for the service of the year ending 30th June, 2018.

3. The sum specified in the third column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the County Revenue Fund under Article 207 (1) of the Constitution. Appropriation of the money granted

4. The supply granted for the services of the year ending on the 30th June, 2018, in respect of Votes R. 4361, R. 4362, R. 4363, R. 4364, R. 4366, R. 4367, R. 4368, R. 4369, R. 4371, R. 4372, R. 4373, R. 4374, R 4376 D. 4361, D. 4362, D. 4363, D. 4364, D. 4366, D. 4367, D. 4368, D. 4369, D. 4371, D. 4372, D. 4373, D. 4374, D. 4376 in accordance with the Appropriation Act No. 1 of 2018. Appropriation in Aid.
