**AN ACT of the County Assembly of Embu to authorize the issue of a sum of money out of the Embu County Revenue Fund and its application towards the service of the year ending 30th June, 2015 and to appropriate that sum, and a sum voted on account by the County Assembly of Embu for certain public services and purposes**

ENACTED by the County Assembly of Embu, as follows—

1. This Act may be cited as the Embu County Appropriation Act, 2014.

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending 30th June, 2015 the sum of Kenya Shillings four billion, fifteen million, twenty-one thousand, four hundred and forty-six and that sum shall be deemed to have been appropriated as from 1st July, 2014, for the services and purposes specified in the schedule

(2) The sum granted out of the County Revenue Fund by subsection (1) includes the sum of Kenya shillings two billion, seven million, five hundred and ten thousand, seven hundred and twenty-three authorized by the County Assembly of Embu on the 25th June, 2014 in accordance with section 134 (1) and (2) of the Public Finance Management Act, 2012, as read together with Section 131 of the County Governments Act, 2012.
