THE EMBU COUNTY APPROPRIATION ACT, 2015**No. 7 of 2015***Date of Assent: 28th July, 2015**Date of Commencement: 31st July, 2015*

AN ACT of the County Assembly of Embu to authorize the issue of a sum of money out of the Embu County Revenue Fund and its application towards the service of the year ending 30th June, 2016 and to appropriate that sum for certain public services and purposes

ENACTED by the County Assembly of Embu, as follows—

1. This Act may be cited as the Embu County Appropriation Act, 2015.

Short Title

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending 30th June, 2016 the sum of Kenya Shillings **Four Billion, Eight Hundred and Seventy Five Million, Seven Hundred and Ten Thousand, Four Hundred and Forty** and that sum shall be deemed to have been appropriated as from 1st July, 2015, for the services and purposes specified in the schedule.

Issue of **KSh. 4,875,710,440** out of the County Revenue Fund for service of the year ending 30th June, 2016 and appropriation of the money granted

3. The capital expenditure of Three Hundred Million Kenya Shillings in respect of Vote D05 sub-vote 3110400 item 3110401 shall only be expended as a component of capital financing instruments approved in accordance with Articles 212 and 213 of the Constitution of Kenya, 2010 and section 140 of the Public Finance Management Act, 2012.

Expenditure of **KSh. 300,000,000** in Vote D05

4. Authority is granted to the Commission on Revenue Allocation to facilitate capital financing for the construction of the County Assembly office complex in accordance with its advisory on financing of huge capital projects.

Authority to CRA to facilitate capital financing.
