# THE HOMA BAY COUNTY SUPPLEMENTARY APPROPRIATION ACT, 2017

#### No. 1 of 2017

Date of Assent: 11th April, 2017

Date of Commencement: 11th April, 2017

AN ACT of the County Assembly of Homa Bay to provide for the Supplementary Appropriation of money from the County Exchequer Account for the requirements of the Homa Bay County Government in the financial year 2016/2017 and to provide for matters incidental thereto

**ENACTED** by County Assembly of Homa Bay as follows—

#### PART I—PRELIMINARY

1. This Act may be cited as the Homa Bay County Supplementary Appropriation Act, 2017.

Short Title

2. (1) Appropriation by county assembly of money from county revenue fund for the requirements of the County in respect of the financial year 2016/2017 to votes and the main divisions within a vote and for the purposes that are specified, are set out in the schedules to this Act.

Appropriation of money for the requirements of the Homa Bay County Government

- (2) The spending of appropriations envisaged in subsection (1) is subject to the provisions of the appropriations law and the Public Finance Management Act 2012.
- (3) The spending of funds withdrawn from the County Revenue Fund before this Act is enacted into law, as envisaged in section 134(4) of the public finance management Act, 2012 shall be included in the appropriation law, under separate votes, for the services for which it is withdrawn.
- 3. (1) The County Treasury may issue the sum of Kenya Shillings Six billion seven hundred and thirty one million, nine hundred and thirteen thousand, five hundred and twenty four out of the County Revenue Fund and apply toward the supply granted for the service of the year ending 30th June, 2017.
- (2) The sum granted by section 2 shall be appropriated for the several services and purposes specified in the

Issue of funds by the County Treasury second column of the First Schedule, in the amounts specified in the third column of that schedule.

- (3) In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those schedules, out of the revenue directed to be applied outside the County Revenue Fund under Article 207(1)(2) of the Constitution.
- 4. An amount within a vote or main division within a vote that is listed as specifically and exclusively appropriated in the schedule to this Act, may be utilized only for the purposes indicated, unless the amount or purpose for which it was allocated is amended by an act of county assembly.
