**THE MERU COUNTY REVENUE BOARD (AMENDMENT) ACT,
2018**

**AN ACT of the County Assembly of Meru to amend the Meru County
Revenue Board Act, 2016**

ENACTED by the County Assembly of Meru, as follows—

Short title and Commencement

1. This Act shall be cited as the Meru County Revenue Board (Amendment) Act, 2018, and shall come into operation upon publication in the *Gazette*.

Amendment of Section 17 of No. 7 of 2016

2. Section 17 of the principal Act is amended in subsection (2) by deleting the words “after deducting the expenses incurred by the board for collection of such revenue.

Amendment of Section 6 of No. 7 of 2016

3. Section 6 (4) of the principal Act is hereby deleted in its entirety.

Amendment of Section 10 of No. 7 of 2016

4. Section 10 of the principal Act is hereby amended by deleting it in its entirety and substituting it therefore with the following section—

10. (1) The County Public Service Board, in consultation with the board, shall appoint such staff as are necessary for the proper discharge of the functions of the board under this Act.

(2) The recruitment of staff of the board shall be through a competitive process and upon such terms and conditions of service as the board, on the advice of the County Public Service Board, may determine.

(3) the board shall ensure that there is sufficient number of staff qualified in matters related to accounting, finance, business, law, information technology or any relevant field necessary for the better carrying out the objects and functions of the board.

(4) The employees of the board shall be paid such remuneration and allowances as shall be determined by the board on the advice of the County Public Service Board and the Salaries and Remuneration Commission.

Amendment of the Schedule to No. 7 of 2016

5. Section 3 (2) of the Schedule to the principal Act is amended by deleting the word “five” appearing between the words “least” and “Members” and substituting it therefore with the word “three”.

Amendment of the Schedule to No. 7 of 2016

6. Section 3 (3) of the Schedule to the principal Act is amended by deleting the words “quarters of the total” appearing between the words “unless” and “members”.

Amendment of the Schedule to No. 7 of 2016

7. Section 3 (4) of the Schedule to the principal Act is amended by deleting the word “five” appearing between the words “be” and “members” and substituting it therefore with the word “three”.

Amendment of the Schedule to No. 7 of 2016

8. Section 3 (5) of the Schedule to the principal Act is amended by deleting the entire subparagraph and substituting it therefore with a new subparagraph reading, “The Chairperson shall preside at every meeting of the board, or in his absence, the person nominated by other members to preside, and who with respect to that meeting and the business transacted thereat, will have all the powers of the Chairperson.
