# NAROK COUNTY SUPPLEMENTARY APPROPRIATION ACT

(2016/17)

AN ACT of COUNTY ASSEMBLY to authorize the issue of certain sums of money out of the County revenue Fund and their application towards the service of the year ending on the 30th June, 2017, and to appropriate those sums for certain public services and purposes

**ENACTED** by Narok County Assembly as follows—

- 1. This Act may be cited as the Supplementary Appropriation Act, Short Title 2016/17.
- 2. The County Treasury may issue the sum of Kenya Shillings Nine Billion, Seventy Nine Million, Five Hundred Fifty One Thousand, Four Hundred Eighty Three Only, (Kshs 9,079,551,483.00) out of the County Revenue Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2017.

Issue of KSh. 9,079,551,483.00. Out of the County Revenue Fund for the service of the year ending 30<sup>th</sup> June. 2017.

Appropriation of the money granted

3. The sum granted by section 2 shall be appropriated for the services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.
