THE NYERI COUNTY FINANCE ACT, 2015

No. 5 of 2015

Date of Assent: 21st December, 2015

Date of Commencement: By Notice

AN ACT of the County Assembly of Nyeri to provide for the amendment of the Revenue Administration Act, 2014 in relation to taxes, fees and charges for various services and other revenue raising measures and for matters incidental thereto

ENACTED by the County Assembly of Nyeri as follows—

PART I—PRELIMINARY

1. This Act may be cited as the Nyeri County Finance Act, 2015 and shall come into operation on such date as the County Executive Committee Member for Finance may appoint and different dates may be appointed for different provisions.

Short Title and Commencement.

2. The Nyeri County Revenue Administration Act, 2014 is amended by—

Amendment of the Nyeri County Revenue Administration Act, 2014.

(a) inserting the following new section immediately after section 10—

11. The taxes, fees and charges set out in “fees and charges” columns of the schedule shall apply for the respective items listed in the description column and at the rates set out therein.

(b) deleting the words “ proposed before the words Fees and Charges;

(c) deleting the word “Schedules” and substituting with the words “Schedule”
