THE KISUMU COUNTY APPROPRIATION ACT

No. 1 of 2013

Date of Assent: 30th June, 2013

Date of Commencement: 1st July, 2013

AN ACT of County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June 2014, and to appropriate those sums for certain public services and purposes.

ENACTED by the County Assembly of Kisumu, as follows—

1. This Act may be cited as the Kisumu County Appropriation Act 2013.

Short Title

2. The County Treasury may issue the sum of eight billion, five hundred and ninety five million, two hundred and eighty five thousand and one hundred and three, out of the County Revenue Funds and apply toward the supply granted for the service of the year ending on the 30th June, 2014.

3. The sum granted by section two shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

Appropriation of the money granted.

4. In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of Revenue directed to be applied outside the County Revenue Fund under Article 207(1) (2) of the Constitution.

Appropriation in Aid

5. The supply granted for the services of the year ending on the 30th June, 2014, in respect of Votes R317-01, R317-02, R317-03, R317-04, R317-05, R317-06, R317-07, R317-08, R317-09, R317-10, R317-11, D317-12 and D317-12, in accordance with Appropriation Act 2013.
