AN ACT of County Assembly of Tana River to authorize the issue of certain sums of money out of the county revenue fund and their application towards the service of the year ending on 30th June, 2018, and to appropriate those sums for certain public services and for connected purposes

ENACTED by the County Assembly of Tana River, as follows—

1. This Act may be cited as the Tana River County Supplementary Appropriation Act, 2018.

Citation and commencement.

2. The Authority granted to the County Treasury on 22nd September, 2017 previously, is amended in respect of the votes specified in the 1st and 2nd columns in the manner indicated in the 3rd and 4th columns of the First Schedule.

Amendment of supply authority previously granted.

3. The supply granted for the services of the year ending 30th June 2018, in respect of the votes, R3161, R3162, R3163, R3164, R3165, R3166, R3167, R3168, R3169, R3170, R3171, R3172, D3161, D3162, D3163, D3164, D3165, D3166, D3167, D3168, D3169, D3170, D3171 and D3172, in accordance with the Tana River County Appropriation Act, 2017.
