ACT, 2014**

*Date of Assent: 7th November, 2014*

*Date of Commencement: 13th November, 2014*

**AN ACT of the County Assembly of Tana River to authorize the issue of certain sums of money out of the County revenue Fund and their application towards the service of the year ending on the 30th June, 2015, and to appropriate those sums for certain public services and purposes**

**ENACTED** by the County Assembly of Tana River, as follows—

1. This Act may be cited as the Appropriation Act, 2014. Short title.
2. The Appropriation Act, 2014 makes provision for giving statutory sanction for public expenditure for the year ending on the 30th June, 2015, on the basis of the budgeted estimates of expenditure 2014/2015 (Recurrent) and the budgeted estimates of Expenditure 2014/2015 (Development) and the appropriation of those amounts. Objects and purpose of the Act.
3. The County Treasury may issue the sum of three billion, five hundred eighty six million, five hundred seventeen thousand three hundred and fifty eight, out of the County Revenue fund and apply it towards the supply granted for the service of the year ending 30th June, 2015. Issue of KSh. 3,586,517,358 out of the County Revenue Fund for the service of the year ending 30th June. 2015.
4. For avoidance of doubt, the sum of money in clause 3 is inclusive of the sum of monies appropriated through the vote on account. Money appropriated through vote on account.
5. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule. Appropriation of sum granted.
6. In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the Consolidated Fund under Article 206 (1) (b) of the Constitution. Appropriations in aid.

7. The supply granted for the services of the year ending on the Vote head codes 30th June, 2015, in respect of Votes R4001, R 4002, R4003, R4004, R4005, R4006, R4007, R4008, R4009, R4010, R4011, R4012, D4001, D4002, D4003, D4004, D4005, D4006, D4007, D4008, D4009, D4010, D4011 and D4012, in accordance with the Appropriation Act, 2014.
