**THE WAJIR COUNTY SUPPLEMENTARY  
APPROPRIATION ACT**

**No. 3 of 2015**

*Date of Assent: 16th September, 2015*

*Date of Commencement: 21st September, 2015*

**AN ACT of the County Assembly of Wajir to authorize the issue of a sum of Money out of the Consolidated Fund and its application towards the service of the year ending on the 30th June, 2016 and to appropriate that Sum and a sum voted on account by the County Assembly for certain public services and purposes**

**ENACTED** by the County Assembly of Wajir, as follows—

1. This Act may be cited as the Wajir County Supplementary Appropriation Act, 2015.

2. (1) The Treasury may issue out of the Consolidated Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2016, the sum of **Kenya Shillings Eight Billion, One Hundred and thirty Nine Million, Seven Hundred and Seven Thousand, Seven Hundred and Sixty Five** and that sum shall be deemed to have been Appropriated as from the 1st July, 2015, for the services and purposes specified in the Schedule.
