**THE TURKANA COUNTY SUPPLEMENTARY  
APPROPRIATION ACT, 2014**

**No. 8 of 2014**

*Date of Assent: 15th May, 2015*

*Date of Commencement: 25th May, 2015*

**AN ACT of the County Assembly of Turkana to authorize the issue of a sum of money out of the Consolidated Fund and its application towards the service of the year ending on the 30th June, 2015 and to appropriate that sum and a sum voted on account by the County Assembly for Certain Public Services and Purposes**

**ENACTED** by the County Assembly of Turkana, as follows —

**1.** This Act may be cited as the Turkana County Supplementary Appropriation Act, 2014.

Short title

**2.** (1) The Turkana County Treasury may issue out of the Consolidated Fund and apply towards the supply granted for the services of the year ending on the 30th June, 2015, the sum of Kenya Shillings **Thirteen Billion, One Hundred and Twenty One Million, Five Hundred Eighty Three Thousand, Three Hundred and Twenty Five Shillings and Sixty One Cents (13,121,583,325.61)** and that sum shall be deemed to have been appropriated as from 1st July, 2014, for the services and purposes specified in the schedule. (2) Fund by subsection (1) includes the sum of Kenya Shillings **Six Billion Five Hundred Sixty Million Seven Hundred Ninety One Thousand, Six Hundred and Sixty Two and Eighty Cents (6,560,791,662.80).**
