THE VIHIGA COUNTY APPROPRIATION ACT

No. 4 of 2014

Date of Assent: 7th July, 2014

Date of Commencement: 11th July, 2014

AN ACT of COUNTY ASSEMBLY to authorize the issue of certain sums of money out of the County revenue Fund and their application towards the service of the year ending on the 30th June, 2015, and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of VIHIGA, as follows—

1. This Act may be cited as the Appropriation Act, 2014.

Short Title

2. The County Treasury may issue the sum of **THREE billion Seven Hundred and Seventy Five Million, Seven Hundred and Forty Three Thousand, Four Hundred and Ninety One**, out of the County Revenue Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2015.

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

Issue of KSh. 3,775,743,491 out of the Consolidated Fund for the service of the year ending 30th June. 2015.

4. In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the Consolidated Fund under Article 206 (1) (b) of the Constitution.

Appropriation of the money granted.

5. The supply granted for the services of the year ending on the 30th June, 2015, in respect of Votes R304-01, R 304-02, R304-03, R304-04, R304-05, R304-06, R304-07, R304-08, R304-09, R304-10, R, R304-11R304-12, D304-01, D304-02, D304-03, D304-04, D304-05, D304-06, D304-07 D304-08 and D304-09, in accordance with the Appropriation Act, 2014.
