**THE TRANS NZOIA COUNTY SUPPLEMENTARY
APPROPRIATION BILL, 2018**

No. 5 of 2018

Date of Assent: 4th January, 2019

Date of Commencement: 4th January, 2019

AN ACT of the County Assembly of Trans Nzoia to authorize the issue of a sum of money out of the County Treasury and its application towards the service of the year ending on the 30th June, 2019 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes

ENACTED by the County Assembly of Trans Nzoia, as follows—

1. This Act may be cited as the Supplementary Appropriation Act, 2018. Issue of KSh. 8,042,560,324 out of the County Treasury for service of the year ending 30th June, 2019 and appropriation of the money granted.

Short title

2. The Treasury may issue out of the County Treasury and apply towards the supply granted for the service of the year ending on the 30th June, 2019, the sum of Kenya Shillings Eight Billion, Forty Two Million, Five Hundred Sixty Thousand, Three Hundred Twenty Four and that sum shall be deemed to have been appropriated as from 1st July, 2018 for the services and purposes specified in the Schedule.

Issue the sum of KSh. 8,042,560,324 out of the County Treasury for service of the year ending 30th June, 2019

3. In addition to the sum granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified out of any money directed to be applied as Appropriations-In-Aid under section 13 (2A) of the Government Financial Management Bill, 2004 No. 5 of 2004.

THE WEST POKOT COUNTY FINANCE ACT, 2013**No. 3 of 2013**

Date of Assent: 27th September, 2013

Date of Commencement: See Section 1

An Act of the West Pokot County Assembly to provide for the various taxes, fees and charges for services, and for other revenue raising measures by the County Government and for matters incidental thereto.

ENACTED by the County Assembly of West Pokot as follows: -

1. This act may be cited as the Finance Act, 2013 and shall come into operation on such a date as the County Executive Committee member for Finance, with the concurrence of the Governor may appoint and different dates may be appointed for different provisions.

PART II – TAXES FEES AND CHARGES PAYABLE AND RATES APPLICABLE

2. (1) The taxes, fees and charges set in the urban and other areas column of the schedule shall apply for the respective items listed in the “items description” column and at the rates set out therein. Urban area charges applies to areas previously covered by municipal council of Kapenguria and other areas charges applies to the rest of the County formerly covered by Pokot county council and Chepareria town council.

(2) For greater certainty, the taxes fees and charges applicable and payable to the Government of the West Pokot County at the commencement of this Act, but those which are not included in the schedule to this Act, shall continue to apply under the existing by Laws of the defunct Local Authorities (County Council of Pokot, Municipal Council of Kapenguria and Chepareria Town Council) until such by-laws are specifically repealed or replaced by County legislation.

3. All directions, resolutions orders and authorizations on or relating to financial management including the collection and administration of taxes, fees and charges given or issued by the defunct County Council of Pokot,

Municipal council of Kapenguria and Chepareria Town Council and subsisting or valid immediately before the cessation of the application of the Local Government Act(now repealed) shall be deemed to have been given, issued or made by or under the authority of the County Assembly until the expiry, amendment or repeal of those directions resolutions, orders and authorizations on financial management and shall continue, with the necessary modifications, apply to the payment and the administration of the taxes fees, charges and other levies under this Act.
