LEGAL NOTICE NO. 92

THE REVISION OF THE LAWS ACT

(Cap. 1)

IN EXERCISE of the powers conferred by section 13 of the Revision of the Laws Act, the Attorney-General makes the following Order:—

THE REVISION OF THE LAWS (RECTIFICATION) ORDER, 2013
