The Magistrates' Jurisdiction (Amendment) Act, 1981 (No. 14 of 1981).	s. 4	Renumber the existing section as subsection (1) and add the following new subsection— (2) Where the court has, at the commencement of this Act, heard the case and pronounced judgement thereon, any appeal therefrom shall proceed as if this Act had not been passed.
