## THE KENYA INDEPENDENCE ORDER IN COUNCIL, 1963

(L.N. 718 of 1963)

IN EXERCISE of the powers conferred by section 4 (4) of the Kenya Independence Order in Council 1963, the Governor-General hereby makes the following Order:—

## THE KENYA (AMENDMENT OF LAWS) (DAIRY INDUSTRY) ORDER, 1964

1. This Order may be cited as the Kenya (Amendment of Laws) (Dairy Industry) Order, 1964, and shall be deemed to have come into operation on the 1st June 1963.

2. The provisions of the Dairy Industry Act (hereinafter referred to as the principal Act) specified in the first column of the Schedule to this Order are amended in the manner specified in the second column of that Schedule. Cap. 336.

3. The principal Act is amended by adding at the end thereof the Schedule following—
