

**THE JUSTICES OF THE PEACE (REPEAL)
ACT, 1983**

No. 10 of 1983

Date of Assent: 7th December, 1983

Date of Commencement: 9th December, 1983

An Act of Parliament to repeal the Justices of the Peace Act and to make consequential amendments to other written laws

ENACTED by the Parliament of Kenya as follows:—

1. This Act may be cited as the Justices of the Peace (Repeal) Act, 1983. Short title.

2. The Justices of the Peace Act is hereby repealed. Repeal of
Cap. 13.

3. (1) The several written laws specified in the first column of the Schedule are amended, in relation to the provisions thereof specified in the second column, in the manner specified in the third column. Amendment of
other written
laws.

(2) Without prejudice to the powers conferred by section 13 of the Revision of the Laws Act, the Attorney-General may by Order rectify any other written law, not specified in the Schedule, which makes reference to justices of the peace in a manner inconsistent with the repeal of the Justices of the Peace Act.
