**An Ordinance to amend various Ordinances concerning agricultural matters so as to confer certain additional powers on the Minister**

ENACTED by the Central Legislature of Kenya, as follows:—

1. This Ordinance may be cited as the Statutory Commodity Boards (Amendment of Laws) Ordinance, 1963. Short title.
2. Section 7 of the Canning Crops Ordinance is amended by inserting therein, immediately after subsection (1) thereof, a new subsection as follows—  
  - (1A) In the exercise of its powers and in the performance of its functions under this Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister. Amendment of section 7 of Cap. 328.
3. Section 14 of the Cereal Producers (Scheduled Areas) Ordinance is amended by inserting therein, immediately after subsection (1) thereof, a new subsection as follows—  
  - (1A) In the exercise of its powers and in the performance of its functions under this Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister. Amendment of section 14 of Cap. 330.

4. Section 6 of the Coffee <sup>Act</sup> Ordinance is amended by adding at the end thereof a new subsection as follows—

(7) In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.

5. Section 8 of the Cotton Lint and Seed Marketing <sup>Act</sup> Ordinance is amended by adding at the end thereof a new subsection as follows—

(4) In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.

(2) In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.

7. The Pyrethrum <sup>Act</sup> Ordinance is amended by inserting therein, immediately after section 14 thereof, a new section as follows—

8. Section 8 of the Sisal Industry <sup>Act</sup> Ordinance is amended by renumbering it as subsection (1) thereof, and by adding thereto a new subsection as follows—

(2) In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.

25A. In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.

12. The Kenya Meat Commission <sup>Act</sup> Ordinance is amended by inserting therein, immediately after section 17 thereof, a new section as follows—

Insertion of new section 17A in Cap. 363.

Commission to comply with Minister's directions.

17A. In the exercise of its powers and in the performance of its functions under this <sup>Act</sup> Ordinance, the Board shall act in accordance with any general or special directions that may be given to it by the Minister.
