THE LAND (PERPETUAL SUCCESSION) REGULATIONS

1. These Regulations may be cited as the Land (Perpetual Succession) Regulations.

2. Every application for a certificate of incorporation shall he accompanied by an application for the registration thereof in Form A in the Schedule.

3. Every application for the recording of a certificate of appointment of new trustees shall be in Form B in the Schedule.

4. Applications for copies of documents or abstract folios shall be in Form C in the Schedule.

5. Applications to inspect the register shall be in Form D in the schedule.

6. The fees payable under the Act shall be as follows—

Fees KSh.

(a) For every certificate of 2,500 incorporation (b) For every application 500 for registration of a certificate of incorporation (Note, - The fee for (a) and (b) shall be paid on Form A at the time of application (c) For every copy of a 1.000 document or abstract folio or extract therefrom (d) For every personal 1,000 search or inspection 500 (e) For every other act, matter or thing not otherwise provided for

6A. The fees prescribed by these Rules include the provision of photostatic copy under the Act.

6B. Government miscellaneous receipts shall be issued upon payment of the fees prescribed in these Regulations.

7. The Registrars of Documents at Nairobi and Mombasa shall keep a supply of forms for the use of the public.

8. The Registrars of Documents shall cause to be impressed on all applications on which fees are paid, and on all copies thereof, a stamp recording the date and time of presentation in such manner (in the case of the original) as to cancel the stamps affixed in payment of fees; and such impression shall, in the absence of fraud, be conclusive evidence of the date and time of presentation and that the fees stated in the application to have been paid have been paid.

9. The Land (Perpetual Succession) Regulations (L.N. 382/1960) are hereby revoked.
