

LEGAL NOTICE No. 104

THE CUSTOMS TARIFF ACT

(Cap. 472)

IN EXERCISE of the powers conferred by section 7 of the Customs Tariff Act, the Minister for Finance and Planning hereby makes the following Order:—

THE CUSTOMS TARIFF (REMISSION) (No. 10) ORDER, 1977

1. This Order may be cited as the Customs Tariff (Remission) (No. 10) Order, 1977, and shall be deemed to have come into operation on the 1st day of January, 1977, and, unless earlier revoked, shall expire on the 30th day of June, 1979.

2. The whole of the import duty and suspended duty payable on the plant, machinery, equipment, tools and spare parts, imported by KeN-ReN Chemicals & Fertilizers Limited for installation in the company's new chemical fertilizer complex to be located in Mombasa, is hereby remitted, provided that no customs duty remission shall be extended to any plant, machinery, equipment, tools and spare parts which are produced and available in Kenya in appropriate type, quality, quantity and specification.

THE FORESTS ACT

(Cap. 385)

KIGANJO FOREST—ALTERATION OF BOUNDARIES

IN EXERCISE of the powers conferred by section 4 (1) of the Forests Act, the Minister for Natural Resources hereby declares that the boundaries of the Kiganjo Forest shall be altered so as to exclude the area described in the Schedule hereto.
