TYPES OF APPARATUS

- Type 1—Weights, spring balances, dead-weight machines, platform machines of capacities not exceeding 250 kg and non-self-indicating instruments.
- Type 2—Platform machines of capacities not exceeding 1,000 kg, self-indicating and semi-self-indicating weighing machines.
- Type 3—Platform machines of capacities exceeding 1,000 kg, weighing bridges and automatic weighing machines.
- Type 4—Balances of precision and weighing instruments incorporating electronic devices.
- Type 5—Liquid measuring instruments defined under rule 137 (a), measures of capacity and bulk measures.
- Type 6—Liquid measuring instruments defined under rule 137 (b) and proving tanks.
- Type 7—Liquid measuring instruments incorporating electronic devices.

LEGAL NOTICE No. 145

THE TRAFFIC ACT

(Cap. 403)

IN EXERCISE of the powers conferred by section 119 of the Traffic Act, the Minister for Transport and Communications makes the following Rules:—

THE TRAFFIC (AMENDMENT) (No. 3) RULES, 1984

1. These Rules may be cited as the Traffic (Amendment) (No. 3) Rules, 1984.

Sub. Leg.

2. The Traffic Rules, in these Rules called the principal Rules, are amended by deleting rule 38A and inserting the following—

Public
service
vehicle
plates.

38A. (1) Every public service vehicle, with the exception of matatus, shall display, on both front and rear elevations, a sign consisting of the letters "P.S.V." in black on a white background of such size as to be clearly visible at a distance of thirty metres.

(2) Every public service vehicle operating as a matatu shall display, on both front and rear elevations, a sign consisting of the letters "P.S.V. (M)" in white on a blue background of such size as to be clearly visible at a distance of thirty metres.

(3) The owner of a public service vehicle being driven on a road which does not carry a sign required by this rule shall be guilty of an offence and liable to a fine not exceeding one thousand shillings.

3. The principal Rules are amended by deleting the heading to Part V and inserting—

**PART V—SPECIAL PROVISIONS RELATING TO MOTOR OMNIBUSES
AND MATATUS**

4. Rules 42, 47, 48, 49, 50, 53, 54, 55, 56, 60 and 61 of the principal Rules are amended by inserting the words "or matatu" immediately after "motor omnibus" in each case.

5. The heading to PART VI of the principal Rules is amended by inserting the words "OR MATATUS" immediately after "MOTOR OMNIBUSES".

6. Rules 62 to 68 (inclusive) are amended by inserting the words "or matatu" immediately after "motor omnibus" wherever it occurs.

7. The principal Rules are amended by deleting rule 86 and inserting the following—

Seating
capacity
of public
service
vehicles.

86. In determining the number of persons for which any public service vehicle has seating capacity, the following provisions shall apply—

(a) in the case of a vehicle registered as a motor omnibus—

(i) where separate seats are provided for each person, one person shall be counted for each separate seat provided;

(ii) where the vehicle is fitted with continuous seats, one person shall be counted for each complete length of sixteen inches measured in a straight line lengthwise on the front of each seat; and where a continuous seat is fitted with arms for the purpose of separating the seating spaces, and the arms are so constructed that they can be folded

back or otherwise put out of use, the seat shall be measured as if it had been fitted with arms;

- (b) in the case of a vehicle registered as a matatu, the seating capacity shall be determined by the certifying officer at the time of mandatory inspection, on the basis of the difference between the tare weight of the vehicle (including any modification work), and the gross weight of the vehicle as specified by the manufacturer, both figures to be expressed in kilogrammes, as applied to the number of units of sixty-five kilogrammes which would be equivalent to the difference between the two load figures.

8. Rule 87 of the principal Rules is amended by inserting the words "or matatu" immediately after "motor omnibus" both in paragraph (1) and in the marginal note.

LEGAL NOTICE No. 146

THE PEST CONTROL PRODUCTS ACT, 1982

(No. 4 of 1982)

IN EXERCISE of the powers conferred by section 15 of the Pest Control Products Act, 1982 the Minister for Agriculture and Livestock Development, after consultation with the Board, makes the following Regulations:—

THE PEST CONTROL PRODUCTS (IMPORTATION AND EXPORTATION) REGULATIONS, 1984

1. These Regulations may be cited as the Pest Control Products (Importation and Exportation) Regulations, 1984 and shall come into operation on the 1st October, 1984.

Citation.

2. (1) No person shall import or export a pest control product for commercial purposes unless that person is in possession of a licence issued under these Regulations.

Importation and exportation prohibited unless licensed.

(2) No licence shall be issued for the importation of a pest control product unless the pest control product is registered in accordance with the Pest Control Products (Registration) Regulations, 1984.

(3) No licence shall be issued under these Regulations unless the Board is satisfied that the provisions of the Pest Control Products Act, 1982 have been complied with.
