THE CONSTITUTION OF KENYA (AMENDMENT) ACT, 1965

(No. 14 of 1965)

IN EXERCISE of the powers conferred by section 6 (4) of the Constitution of Kenya (Amendment) Act, 1965, the President hereby makes the following Order:—

THE CONSTITUTION (AMENDMENT OF LAWS) (RATING AND VALUATION FOR RATING) ORDER, 1965

1. This Order may be cited as the Constitution (Amendment of Laws) (Rating and Valuation for Rating) Order, 1965, and shall be deemed to have come into operation on the 12th December 1964.

2. The provisions of the Rating Act, 1964, and of the Valuation for Rating Act specified in the first column of the Schedule to this Order are amended in the manner specified in relation thereto in the second column of that Schedule.
