IN EXERCISE of the powers conferred by section 3 of the Accountant General (Transfer of Functions) Ordinance, 1955, the Minister for Finance and Development hereby makes the following Order:—

THE EDUCATION ORDINANCE, 1952
(No. 58 of 1952)

IN EXERCISE of the powers conferred by section 42 of the Education Ordinance, 1952, the Director of Education hereby makes the following Order:—

THE WEST CENTRAL AND WESTERN REGIONAL
EDUCATION BOARDS (ALTERATION OF AREAS
OF JURISDICTION) ORDER, 1956

1. This Order may be cited as the West Central and Western Regional Education Boards (Alteration of Areas of Jurisdiction) Order, 1956.

2. (1) As and from the 1st day of July, 1956, the West Central Regional Education Board shall be entitled to exercise jurisdiction over the Rift Valley Province and the Turkana District only.

(2) The Order establishing the West Central Regional Education Board shall be varied accordingly.

3. (1) As and from the 1st day of July, 1956, the Western Regional Education Board shall be entitled to exercise jurisdiction over the Kericho District and that portion of the Nyanza District Council area lying without the Kericho District, in addition to the areas specified in the Order establishing the said Board.

(2) The Order establishing the Western Regional Education Board shall be varied accordingly.
