An Act of Parliament to amend the Registered Land Act

ENACTED by the Parliament of Kenya as follows:-

Short title. 1. This Act may be cited as the Registered Land (Amendment) Act, 1987.

2. The several provisions of the Registered Land Act specified in the first column of the First Schedule are amended in the manner specified in the second column of that Schedule.

3. The form of land certificate in the Second Schedule to the Registered Land Rules is revoked and replaced by the form of title deed specified in the Second Schedule to this Act.
