The National Assembly Remuneration Act (Cap. 5)	First Schedule	Delete "£4,945" from the item in which that expression appears and substitute "£5,410".  Delete "Deputy Chief Whip and" from the item in which those words appear.  Insert a new item immediately before "Members of the Chairmen's Panel" by inserting "Deputy Chief Whip", "£2,340" and "Sitting allowance, constituency allowance and fifty per cent of the house allowance; responsibility allowance of £2,550 a year." in the first, second and third columns of the Schedule respectively.
The Judicature Act (Cap. 8).	s. 7(1)	Delete "nineteen" and insert "twenty-four".

The Advocates Act (Cap. 16).	s. 27 (1)	Delete paragraph (b) and insert the following—  (b) by producing evidence satisfactory to the Registrar that the applicant has paid to the Society the fee prescribed for a practising certificate and the annual subscriptions payable for the time being to the Society and to the Advocates Benevolent Association.
	s. 86	Delete the whole section and insert the following—  Application of certain fees, etc. 86. All admission fees received by the Registrar under section 10 (2) or 19 (5), and all fees received by the Registrar in respect of replacing an advocate's name on the Roll under section 75, shall be paid by the Registrar to the Society, and those fees, together with the fees for practising certificates and the Society's annual subscriptions, both of which shall be collected by the Society, may be applied by the Society to all or any of the objects of the Society.
The Trade Unions Act (Cap. 233).	s. 38 (4)	Delete and insert the following—  (4) If, after such enquiry as he deems necessary, the Registrar is not satisfied as to the validity of any appointment or the propriety of any proposed correction to the register, he may refuse to register the change of officers or to correct the register, or he may refer the matter to a Trade Unions Tribunal composed of one or more independent persons appointed by the Minister, and in that case the Tribunal shall inquire into the matter and make its recommendations thereon to the Registrar, who shall thereupon register or refuse to register, or correct or refuse to correct, in accordance with those recommendations
The Oil Production Act (Cap. 308).	s. 2	Delete the definition of "licence" and insert—  "licence" means an exploration licence, a prospecting licence or a licence to mine for oil, as the case may require;

	s. 3 (1)	Delete the words "land situate within Kenya, including that" and insert "the whole of Kenya and to the continental shelf and to every".
	s. 3 (2)	Delete the words "explore or prospect" and insert "explore, prospect or mine".
	s. 9	Delete the words "to explore and prospect for oil and leases to mine for oil" in the second and third lines and insert "and leases to explore, prospect or mine for oil".
	s. 10	In paragraph (a) delete the word "crude" in the third line.
The Merchant Shipping Act (Cap. 389).	s. 317 (1)	Delete paragraph (c) and insert the following— (c) to give effect to and for the better carrying out of the purposes of this Act, to provide generally for regulating merchant shipping and for carrying out and giving effect to any convention thereon.
The Court Brokers Act, 1981 (No. 1 of 1981).	s. 27	Delete paragraph (a) and insert the following— (a) until 31st December, 1981.
