THE SUPPLEMENTARY APPROPRIATION ACT, 1964

No. 2 of 1964

Date of Assent: 26th March 1964

Date of Commencement: 7th April 1964

An Act of Parliament to authorize the issue of a sum of money out of the Consolidated Fund and its application towards the service of the year ending 30th June 1964, and to appropriate that sum for certain public services and purposes

ENACTED by the Parliament of Kenya, as follows:-

1. This Act may be cited as the Supplementary Appropriation Act, 1964.

Short title.

2. The Treasury may issue out of the Consolidated Fund and apply towards the supply granted for the service of the year ending on the 30th June 1964 the sum of two million eight hundred and twenty-five thousand and forty-eight pounds.

Issue of £2,825,048 out of Consolidated Fund for service of year ending 30th June 1964.

3. The sum granted out of the Consolidated Fund by this Act shall be appropriated for the services and purposes specified in the Schedule to this Act.

Appropriation of money granted.

4. In addition to the sum granted out of the Consolidated Fund as aforesaid, there may be applied out of any money directed under section 15 of the Exchequer and Audit Act to be applied as an appropriation-in-aid of the grants for the services and purposes specified in the Schedule to this Act the sums respectively set forth in the last column of that Schedule.
